Amendment to the Future Land Use Map in the Rural Municipality of North Shore 2021 Official Plan (PID 575910)



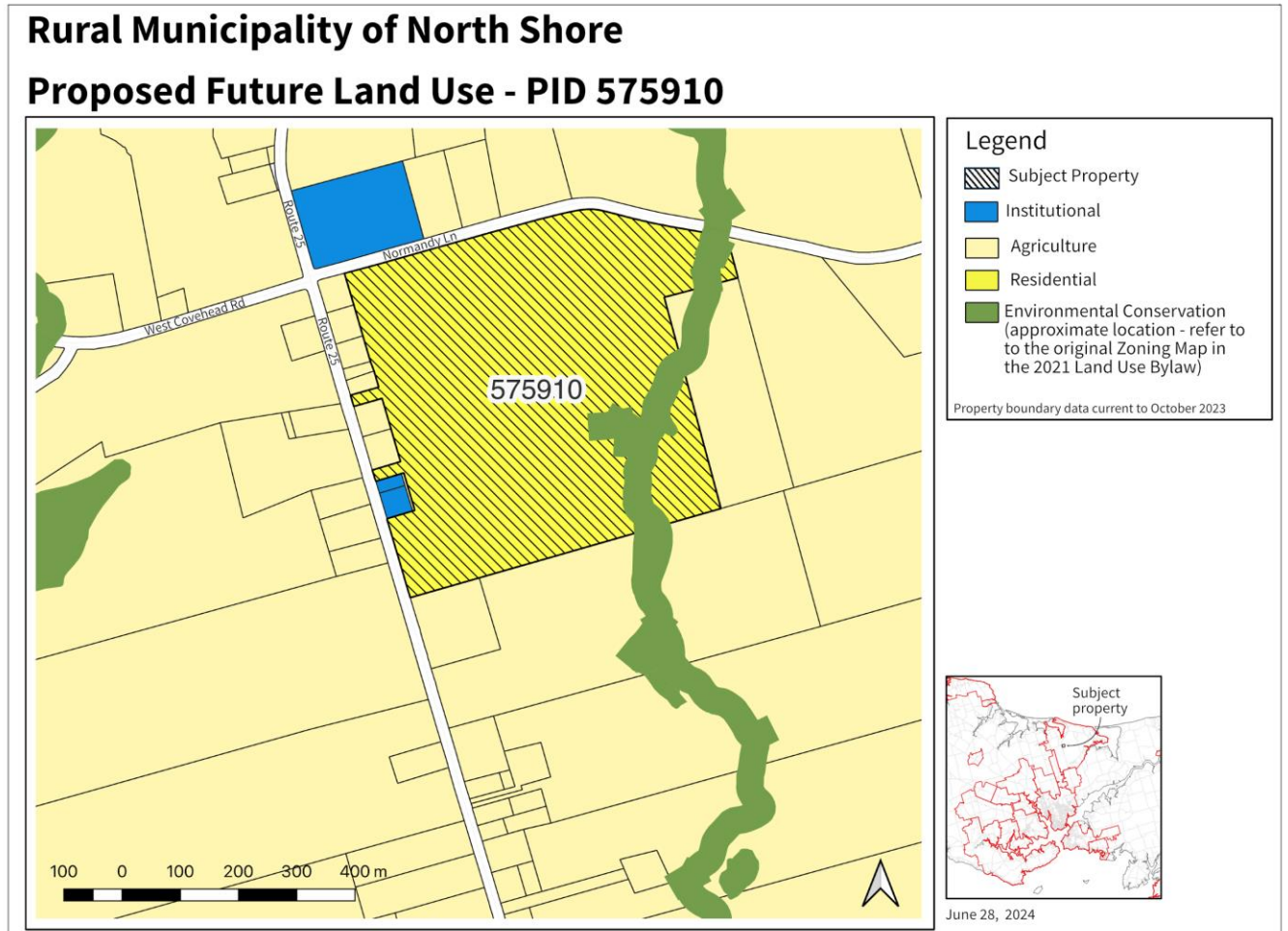
Effective Date

Bylaw BY-04, A Bylaw to Amend the Rural Municipality of North Shore 2021 Land Use Bylaw (PID number 575910)



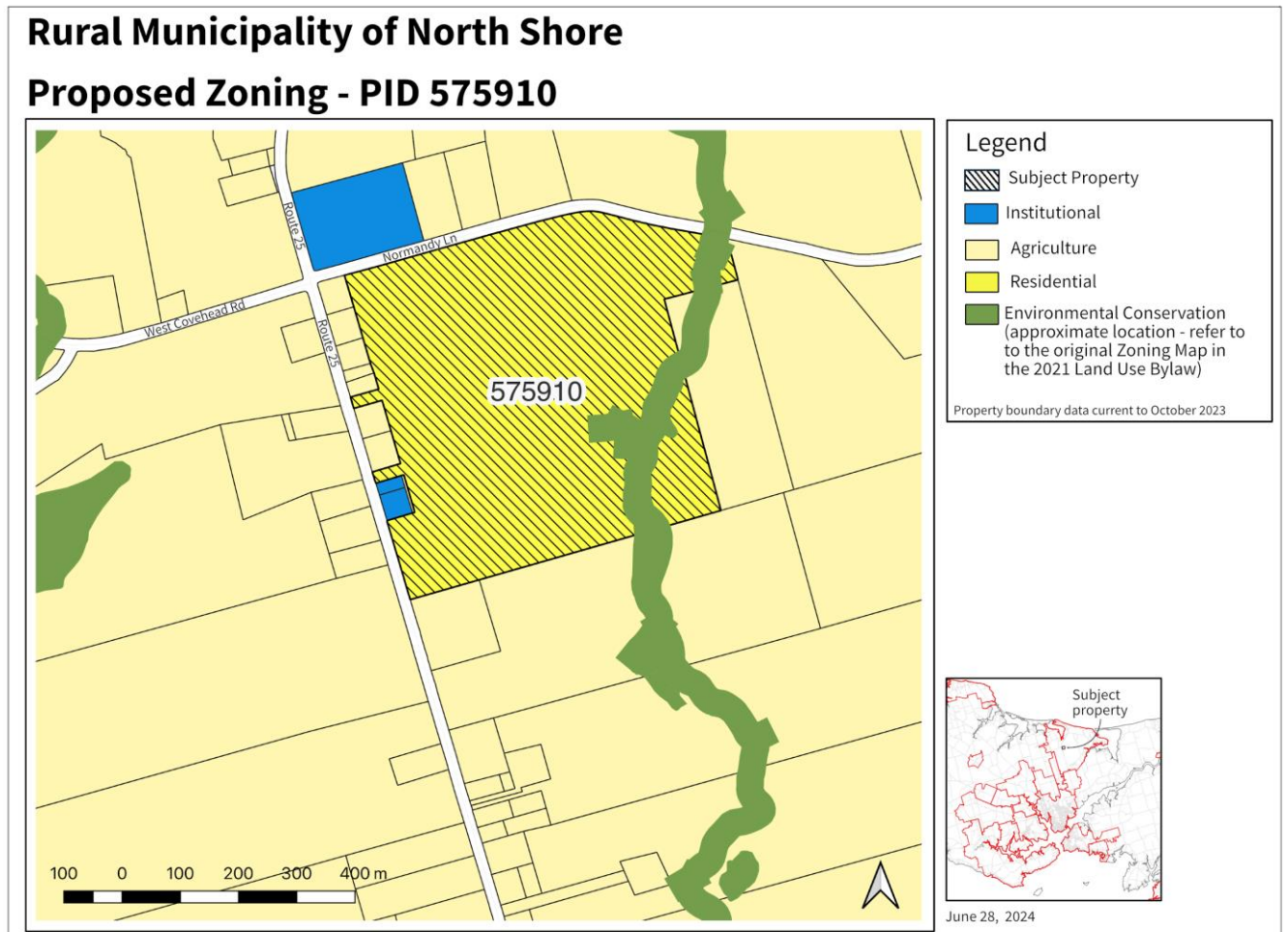
Effective Date
